Nexus Energy Innovation Private Limited, a firm registered with the Registrar of Firms, Islamabad, having its registered office at Plot #66, Street 02, Razaq Valley, Kuree Road, Islamabad (hereinafter referred to as the "First Party," which expression, where the context so admits or requires, shall include its legal representatives, successors-in-interest, executors, and assigns), of the FIRST PART.

WHEREAS, the Service Provider is, inter alia, engaged in the business of petroleum products and holds valid authorizations and approvals from the Oil and Gas Regulatory Authority (OGRA) and authorized Oil Marketing Companies (OMCs) to carry on the business as an authorized seller of petroleum products.

WHEREAS, the Service Provider represents that it possesses sufficient means of transportation to facilitate the delivery of diesel to the branches/offices of *Customer Name*

under the terms and conditions set forth herein;

AND WHEREAS, upon the offer of the Service Provider, *Customer Name* has agreed to avail itself of the Service Provider's services for the delivery of diesel to operate its electric generator sets, subject to the following terms and conditions.

NOW THEREFORE, THIS AGREEMENT WITNESSETH AS FOLLOWS:

Upon execution of this Agreement for the purpose of purchasing diesel and making payments thereof, the following terms and conditions are mutually agreed upon by the parties:

- a) The Service Provider shall deliver diesel to the doorstep of *Customer ABC*'s branches/offices as per their requirements.
- b) The Service Provider shall supply diesel through dedicated vehicles equipped with digital meters for accurate quantity measurement.
- c) All delivery challans must be signed and stamped by an authorized representative of *Customer ABC* at the receiving branch/office.
- d) The Service Provider shall extend a credit period of thirty (30) days to Customer ABC.
- e) The Service Provider agrees to offer *Customer ABC* a per-liter discount of Rs. 0.00/- on the OGRA rate for all invoices submitted during the validity of this Agreement.
- f) The Service Provider shall ensure timely delivery of standard quality diesel, suitable for *Customer ABC*'s generator sets, and shall bear all costs and resources for such delivery. *Customer ABC* reserves the right to independently inspect the diesel quality at any time through OGRA-approved laboratories at the Service Provider's expense.
- g) The Service Provider shall ensure delivery within one (01) hour to *Customer ABC*'s branches, using supply vans equipped with digital fuel dispensers. The delivered quantity shall be verified by *Customer ABC*'s Operations Manager or In-Charge. No additional service charges shall be applicable for delivery.

i) Customer ABC reserves the right to terminate the Agreement with 24 hours' notice if Nexus Energy Innovation fails to meet the contractual obligations.

j)	Nexus Energy Innovation shall be fully liable for any repair or maintenance costs of the generators arising due to the supply of substandard diesel.
k)	Customer ABC shall make payments via cross cheques within twenty-five (25) days of receipt of invoices.

I) Customer ABC shall not be held responsible for any accidents, damages, or losses incurred during the fuel delivery process by Nexus Energy Innovation.
